

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Additions to the Master List for the 2020 Non-Gaming Per Capita  
Distribution for Eligible Tohono O'odham Adult Members)**

**RESOLUTION NO. 20-290**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation Vests the Tohono O'odham**  
2 **Legislative Council with the power to "manage any funds within the exclusive**  
3 **control of the Tohono O'odham Nation, including proceeds derived from lands**  
4 **and resources of the Tohono O'odham Nation" (Constitution, Article VI, Section**  
5 **1(d)(2)); and**

6 **WHEREAS, the Legislative Council adopted the 2020 Non-Gaming Per Capita Plan by**  
7 **Legislative Council Resolution No. 20-070; and**

8 **WHEREAS, by Resolution No. 20-244, the Tohono O'odham Legislative Council approved the**  
9 **Master List and approved the total number of verified eligible adult members for**  
10 **the 2020 Non-Gaming Per Capita as 24,947; and**

11 **WHEREAS, the Tohono O'odham Membership Services Enrollment Program has identified**  
12 **100 adult members who were left off the Master List for the 2020 Non-Gaming Per**  
13 **Capita and have identified the additional adult members in the attached list; and**

14 **WHEREAS, Tohono O'odham Membership Services has prepared and submitted to the**  
15 **Tohono O'odham Legislative Council the Additions to the Master List for Eligible**  
16 **Tohono O'odham Adult Members for review and approval for the 2020 Non-**  
17 **Gaming Per Capita Distribution; and**

18 **WHEREAS, the total number of eligible Tohono O'odham adult members for the 2020 Non-**  
19 **Gaming Per Capita is 25,047 members; and**

20 **WHEREAS, the disbursement of funds to each eligible adult Tohono O'odham member is**  
21 **contingent upon verification of a member and further certification by the Tohono**  
22 **O'odham Legislative Council; and**

23 **WHEREAS, the Rules Committee has reviewed the Additions to the Master List for the 2020**  
24 **Non-Gaming Per Capita Distribution for Eligible Tohono O'odham Adult**  
25 **members and recommends its approval.**

26 **NOW THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
27 **Additions to the Master List for the 2020 Non-Gaming Per Capita Distribution for**  
28 **Eligible Tohono O'odham Adult Members for use by Membership Services in the**  
29 **administration of the 2020 Non-Gaming Per Capita Plan provided that:**

- 30 (1) **Disbursement of the 2020 Non-Gaming Per Capita payment to each**  
31 **eligible adult Tohono O'odham member is contingent upon verification of**  
32 **member's eligibility and further certification by the Tohono O'odham**  
33 **Legislative Council.**

- 1 (2) Approval of the Master List shall not constitute the enrollment of any  
2 person that is not otherwise duly enrolled in accordance with the  
3 Constitution and laws of the Tohono O'odham Nation.  
4 (3) The Master list may be corrected by resolution of the Tohono O'odham  
5 Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>  
7 day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;  
8 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
9 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the  
10 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
12 18, 1934 (48 Stat.984).
