13	WHEREAS,	according to the Master List for the 2020 Non-Gaming Per Capita Distribution for
14		Eligible Tohono O'odham Minor Members, the total of eligible Tohono O'odham
15		Minor Members for the 2020 Non-Gaming Per Capita is 10,205 members; and
16	WHEREAS,	the Rules Committee has reviewed the Master List for the 2020 Non-Gaming Per
17		Capita Distribution for Eligible Tohono O'odham Minor Members and
18		recommends approval.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the

28		person that is not otherwise duly enrolled in accordance with the
29		Constitution and laws of the Tohono O'odham Nation.
30		(3) The Master list may be corrected by resolution of the Tohono O'odham
