7	WHEREAS,	the FY 2020 Office of Attorney General Budget in the amount of \$2,656,958.37 was
8		approved by Resolution No. 19-380, and subsequently amended by Resolution No.
9		19-471 in the amount of \$3,056,958.37; and
10	WHEREAS,	the Office of Attorney General has prepared and submitted for review and
11		approval its FY 2020 Office of Attorney General Budget Amendment No. 2, which is
12		incorporated by this reference and which will adjust operational and/or
13		personnel line items; and
14	WHEREAS,	the FY 2020 Office of Attorney General Budget Amendment No. 2 will not increase
15		the Office of Attorney General Budget amount of \$3,056,958.37; and
16	WHEREAS,	the Domestic Affairs and Budget and Finance Committees have reviewed the FY
17		2020 Office of Attorney General Budget Amendment No. 2 and recommend its
18		approval.

20		FY 2020 Office of Attorney General Budget Amendment No. 2.
