

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 Office of Attorney General Budget Amendment No. 2)**

**RESOLUTION NO. 20-295**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2020 Office of Attorney General Budget in the amount of \$2,656,958.37 was  
8 approved by Resolution No. 19-380, and subsequently amended by Resolution No.  
9 19-471 in the amount of \$3,056,958.37; and

10 **WHEREAS,** the Office of Attorney General has prepared and submitted for review and  
11 approval its FY 2020 Office of Attorney General Budget Amendment No. 2, which is  
12 incorporated by this reference and which will adjust operational and/or  
13 personnel line items; and

14 **WHEREAS,** the FY 2020 Office of Attorney General Budget Amendment No. 2 will not increase  
15 the Office of Attorney General Budget amount of \$3,056,958.37; and

16 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY  
17 2020 Office of Attorney General Budget Amendment No. 2 and recommend its  
18 approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
20 **FY 2020 Office of Attorney General Budget Amendment No. 2.**

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
22 Nation chairperson or any designated official is authorized to administer and  
23 expend the FY 2020 Office of Attorney General Budget as amended, provided that  
24 any amendments or modifications shall be submitted for prior approval by the  
25 Tohono O'odham Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
27 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**  
28 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**
