

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Gu-Vo District Administration Budget Amendment No. 2 and
FY 2020 Pia-Oik Community Budget Amendment No. 2)**

RESOLUTION NO. 20-298

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 Gu-Vo District Budget in the amount of \$3,574,243.43 was authorized
13 by Gu-Vo District Council Resolution No. GV-19-094 and approved by Legislative
14 Council Resolution No. 19-354, and subsequently amended by Gu-Vo District
15 Council Resolution No. GV-20-016 and approved by Legislative Council
16 Resolution No. 20-116 in the amount of \$3,853,547.32; and

17 **WHEREAS,** by Gu-Vo District Council Resolution No. GV-20-047 and Resolution No. GV-20-
18 037, the Gu-Vo District has authorized and submitted for review and approval its
19 FY 2020 Gu-Vo District Administration Budget Amendment No. 2 and FY 2020 Pia-
20 Oik Community Budget Amendment No. 2, which are incorporated by these
21 references and which will adjust operational and/or personnel line items; and

22 **WHEREAS,** the FY 2020 Gu-Vo District Administration Budget Amendment No. 2 and FY 2020
23 Pia-Oik Community Budget Amendment No. 2 will not change the FY 2020 Gu-Vo
24 District Budget amount of \$3,853,547.32; and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Gu-Vo District
26 Administration Budget Amendment No. 2 and FY 2020 Pia-Oik Community Budget
27 Amendment No. 2 recommends its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 FY 2020 Gu-Vo District Administration Budget Amendment No. 2, which will not
30 change the budget amount of \$2,423,849.95, and the FY 2020 Gu-Vo District Pia-
31 Oik Community Budget Amendment No. 2, which will not change the budget
32 amount of \$357,424.34.

4 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 Gu-Vo
5 **District Budget, as amended shall be managed and expended in accordance with**
6 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**
7 **Nation's laws, provided that any amendments or modifications shall be**
8 **authorized under District Council resolution and submitted for prior approval by**
9 **the Tohono O'odham Legislative Council.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
11 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
12 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
13 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
14 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
15 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
16 **(48 Stat.984).**
