The management of these funds shall be only by a treasurer or other authorized officer of the district council who has 6 7 furnished a surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and all expenditures of these funds shall be by checks 8 9 signed by such treasurer or other authorized officer and the chairman or vice chairman of the district council. 10 11 ; and 12 WHEREAS. the FY 2020 Sells District Administration and Community Budgets in the amount of \$7,393,075.92 was authorized by Sells District Council Resolution No. SD 74 19 13 and approved by Legislative Council Resolution No. 19-350 and subsequently 14 amended by Sells District Council Resolution Nos. SD-40-20, SD 60-20, and SD-71-15 20 and approved by Legislative Council Resolution Nos. 20-079, 20-113, and 20-183 16 17 respectively; and 18 WHEREAS, by Sells District Council Resolution No. SD-96-20, the Sells District has prepared 19 and submitted for review and approval its FY 2020 Sells District Administration and Community Budgets Amendment No. 4, which is incorporated by this 20 21 reference and which will adjust operational and/or personnel line items; and 22 WHEREAS. the FY 2020 Sells District Administration and Community Budgets Amendment 23 No. 4 will not change the total budget amount of \$7,393,075.92; and 24 the Budget and Finance Committee has reviewed the FY 2020 Sells District WHEREAS. Administration and Community Budgets Amendment No. 4 and recommend its 25 26 approval. NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 27 28 FY 2020 Sells District Administration and Community Budgets Amendment No. 4, which does not change the total budget amount of \$7,393,075.92. 29 30 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 Sells 31 District Administration and Community Budgets as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the 32 Tohono O'odham Nation and the Nation's laws, provided that any amendments or 33
