

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 San Xavier District Budget Amendment No. 3)**

RESOLUTION NO. 20-301

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 San Xavier District Budget in the amount of \$10,281,911.53 was
13 authorized by San Xavier District Council Resolution No. SXDC 08-19-12 and
14 approved by Legislative Council Resolution No. 19-356, and subsequently
15 amended by Legislative Council Resolution No. 20-078 in the amount of
16 \$10,356,911.53, and further amended by Legislative Council Resolution No. 20-
17 112 in the amount of \$10,881,911.53; and

18 **WHEREAS,** the San Xavier District has applied for and received a \$5,000.00 Native American
19 Agricultural Fund (NAAF) Supplemental Grant for COVID-19 supplies and
20 materials and has received donations in the amount of \$6,666.66 from the BOA
21 Foundation and \$1,200.00 from the Duffy family; and

22 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 08-20-08, the San Xavier
23 District has authorized and submitted for review and approval its FY 2020 Budget
24 Amendment No. 3, which is incorporated by this reference; and

25 **WHEREAS,** the FY 2020 San Xavier District Budget Amendment No. 3 will increase the FY 2020
26 San Xavier District Budget by \$12,866.66 from \$10,881,911.53 to \$10,894,778.19 by
27 incorporating the NAAF Supplemental Grant funds and donations from the BOA
28 Foundation and the Duffy family; and

29 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 San Xavier District
30 Budget Amendment No. 3 and recommends approval.

31 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
32 FY 2020 San Xavier District Budget Amendment No. 3, which includes a \$12,866.66
33 increase from \$10,881,911.53 to \$10,894,778.19 that shall be funded by the NAAF
34 Supplemental Grant funds and donations from the BOA Foundation and the Duffy
35 family.

1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 San
 2 Xavier District Budget, as amended shall be managed and expended in
 3 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
 4 Nation and the Nation's laws, provided that any amendments or modifications
 5 shall be authorized under a District Council resolution and submitted for prior
 6 approval by the Tohono O'odham Legislative Council.

7 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH
 8 day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
 9 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
 10 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
 11 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
 12 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
 13 (48 Stat.984).
