## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Approving Grantees for the Disbursement of the 2020 Gaming Compact Section 12(d) 12% Contribution)

1	WHEREAS,	by Resolution No. 02-562, the Tohono O'odham Nation ("Nation") approved a new
2		tribal-state gaming compact ("Compact") with the State of Arizona; and
3	WHEREAS,	pursuant to Section 12 of the Compact, the Nation agreed to make certain tribal
4		contributions in consideration for substantial exclusivity covenants by the State,
5		and pursuant to Section 12(d), the Nation agreed to contribute 12% of its total
6		annual contribution (the "12% Distribution") to cities, towns, and counties for
7		services that benefit the general public; and
8	WHEREAS,	pursuant to Section 12(e)(2) of the Compact, the 12% Distribution disbursement
9		shall be transmitted to the recipient no later than sixty (60) days after the last day
10		of the Gaming Facility Operator's fiscal year; and
11	WHEREAS,	Section 7(d) of the Gaming Enterprise Charter, 16 T.O.C. Chapter 2, directs the
12		Tohono O'odham Gaming Enterprise to "timely pay the contribution required
13		under Section 12(d) of the Compact in accordance with the directives of the
14		Legislative Council. The Enterprise shall comply with all accounting, auditing,
15		and record keeping requirements and obligations of the Nation under the
16		Compact relating to the payment of regulatory costs and tribal contributions as
17		required under Section 12 of the Compact."; and
18	WHEREAS,	the Commerce Committee and the Chairman of the Nation recommend that the
19		Legislative Council approve awards to grantees for the designated purposes and
20		in the amounts appearing in the 2020 12% Distribution List, which is
21		incorporated by this reference.
22	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
23		payments to the listed grantees for the purposes identified in the 2020 12%
24		Distribution List, which shall remain confidential and shall not be reported or
25		disclosed; provided, that the identity of the organizations receiving individual
26		awards may be released without disclosing the amount of the 2020 12%
27		Distribution.
28	BE IT FURTH	ER RESOLVED that if the designated grantees are unable to receive and expend the
29		12% Distribution in accordance with this resolution and the Compact, the
30		Commerce Committee and Nation's Chairperson are authorized to jointly
31		approve amendments to the 2020 12% Distribution List awards, that are solely for
32		purposes permitted under Section 12(d) of the Compact, and that collectively do
33		not exceed 10% of the total Distribution amount.

BE IT FURT	HER RESOLVED that the Nation's Chairperson is authorized to administer and
	approve grantee requests to reallocate or spend unused remaining funds, that
	are solely for purposes permitted under Section 12(d) of the Compact and that fall
	within the scope of work identified in the grantee proposal as approved by
	Council.

BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the Chairman of the Nation to execute grant agreements and related documents with the grantees as necessary in accordance with the 2020 12% Distribution List and the terms of this resolution.

BE IT FINALLY RESOLVED that the Tohono O'odham Gaming Enterprise, in consultation with the Office of the Chairman, is directed to issue checks in the amounts approved in the 2020 12% Distribution List or as otherwise provided by this resolution to either the grantee or the flow-through municipality; provided that such checks shall be issued no later than sixty (60) days after the last day of the Gaming Facility Operator's fiscal year and shall be mailed via certified mail to the designated grantees with copies of the approved grant agreements provided to the Office of the Attorney General.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup> day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section (d)(2) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
