1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the power "to employ legal counsel for the protection and advancement of the
3		rights of the Tohono O'odham Nation" (Constitution, Article VI, Section 2(a)); and
4	WHEREAS,	the Tohono O'odham Nation has for several years contracted with The Clark Law
5		Firm. P.C. for legal services related to employment issues in which the Office of
6		Attorney General is unable to provide legal advice due to conflict of interest; and
7	WHEREAS,	the Tohono O'odham Legislative Council by Resolution No. 19-460 approved the
8		Attorney Contract regarding employment issues with the law firm of The Clark
9		Law Firm, P.C., in the amount of \$15,000 for the period of October 1, 2019 through
10		September 30, 2020; and
11	WHEREAS,	the Human Resources Department has determined that additional legal
12		assistance is required during the current fiscal year with regard to the
13		employment issues; and
14	WHEREAS,	the Human Resources Department has prepared an Amendment to the Attorney
15		Contract with The Clark Law Firm, P.C. regarding employment issues to increase
16		the budget amount from \$15,000 to \$35,000 for the period of October 1, 2019
17		through September 30, 2020; and
18	WHEREAS,	the Attorney Contract regarding employment issues is under the oversight of the
19		Attorney General, but is paid for out of the Human Resources Department budget;
20		and
21	WHEREAS,	the Human Resources Development Committee has reviewed the amendment to
22		the Attorney Contract and recommends its approval.
23	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
24		Amendment to the Attorney Contract regarding employment issues with The
25		Clark Law Firm, P.C., in the amount of \$35,000 for the period of October 1, 2019
26		through September 30, 2020, which shall be funded from the Human Resources
27		Department budget.
28	BE IT FINALL	Y RESOLVED by the Tohono O'odham Legislative that the chairperson of the Nation
29		is authorized to execute the $\Lambda$ mendment to the $\Lambda$ ttorney Contract in substantially
30		the form attached.
