**RESOLUTION NO. 20-311** 

1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the authority to "promote, protect and provide for public health, peace, morals,
3		education and general welfare of the Tohono O'odham Nation and its members"
4		and to "consult, negotiate and conclude agreements and contracts on behalf of
5		the Tohono O'odham Nation with Federal, State and local governments and other
6		Indian tribes within the authority of the Tohono O'odham Council."
7		(Constitution, Article VI, Section 1(c)(2) and Section 1(f)); and
8	WHEREAS,	the Health Resources and Services Administration, an agency of the U.S.
9		Department of Health and Human Services, has announced the formation of the
10		Health Resources and Services Administration ("HRSA") Tribal Advisory Council
11		("TAC"), a significant government-to-government vehicle to consult with Indian
12		Country; and
13	WHEREAS,	the HRSA TAC will be established to engage in regular and meaningful
14		collaboration and consultation with tribal officials on policies that have tribal
15		implications and substantial direct effect on Indian tribes, and will be the vehicle
16		for acquiring a broad range of tribal views, determining the impact of HRSA
17		programs on the American Indian and Alaska Natives health systems and
18	i	population, developing innovative approaches to deliver health care, and
19		assisting with effective tribal consultation; and
20	WHEREAS,	the HRSA is seeking nominations of eligible tribal officials to serve as HRSA TAC
21		delegate members to fill up to 12 voluntary positions on the HRSA TAC, one
22		authorized tribal representative (and one designated alternate) from each of the
23		12 Indian Health Service geographic areas to serve terms of up to 2 years; and
24	WHEREAS,	the Health and Human Services Committee recommends nominating
25		Representative Leander V. Mase for appointment as the HRSA TAC Tucson Area
26		delegate member and Representative Sandra Ortega as alternate to
27		Representative Leander V. Mase.
28	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates
29		Representative Leander V. Mase for appointment as the Health Resources and
30		Services Administration Tribal Advisory Council Tucson Area delegate member
31		and Representative Sandra Ortega as alternate to Representative Leander V.
32		Mase.
