12	WHEREAS,	by Baboquivari District Council Resolution No. 2020-B-75, the Baboquivari
13		District has authorized the FY 2021 Baboquivari District Budgets, which are
14		incorporated by these references, in the amount of \$3,074,043.86; and
15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2021 Baboquivari District
16		Budgets and recommends its approval.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2021 Baboquivari District Budgets effective October 1, 2020 in the amount of
19		\$3,074,043.86, which shall be funded by the August 2020 District Allocation.
20	BE IT FINAL	LLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021
21		Baboquivari District Budgets shall be managed and expended in accordance with
22		Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the
23		Nation's laws, provided that any amendments or modifications shall be
24		authorized under District Council resolution and submitted for prior approval by
25		the Tohono O'odham Legislative Council.
