

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Gu-Vo District Budget)**

RESOLUTION NO. 20-318

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** by Gu-Vo District Resolution No. GV-20-040, the Gu-Vo District has authorized
13 **the FY 2021 Gu-Vo District Budget, which is incorporated by this reference, in the**
14 **amount of \$3,074,043.85; and**

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Gu-Vo District
16 **Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 **FY 2021 Gu-Vo District Budget in the amount of \$3,074,043.85, which shall be**
19 **funded by FY 2021 district gaming allocation.**

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Gu-Vo
21 **District Budget shall be managed and expended in accordance with Article IX,**
22 **Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws,**
23 **provided that any amendments or modifications shall be authorized under**
24 **District Council resolution and submitted for prior approval by the Tohono**
25 **O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD**
27 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 2,628.6 FOR;**
28 **547.1 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**
29 **by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
