The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 by Pisinemo District Council Resolution No. 20-P-29, the Pisinemo District has WHEREAS. 13 authorized the FY 2021 Pisinemo District Operations Budget, which is 14 incorporated by this reference, in the amount of \$3,074,043.86; and 15 the Budget and Finance Committee has reviewed the FY 2021 Pisinemo District WHEREAS. 16 Operations Budget and recommends its approval. NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 17 18 FY 2021 Pisinemo District Operations Budget effective October 1, 2020 in the 19 amount of \$3,074,043.86, which shall be funded by the August 2020 District 20 Allocation. 21 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Pisinemo 22 District Operations Budget shall be managed and expended in accordance with 23 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the 24 Nation's laws, provided that any amendments or modifications shall be 25 authorized under District Council resolution and submitted for prior approval by 26 the Tohono O'odham Legislative Council. 27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD 28 day of <u>SEPTEMBER, 2020</u> at a meeting at which a quorum was present with a vote of <u>3.175.7</u> FOR; 29 <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by 30 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono 31 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -

Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
