14		incorporated by this reference, in the amount of \$3,074,043.83; and
15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2021 Sells District
16		Administration and Community Budgets and recommends its approval.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2021 Sells District Administration and Community Budgets effective October
19		1, 2020 in the amount of \$3,074,043.83, which shall be funded by the August 2020
20		District Allocation.
