

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Schuk Toak District Budget)

RESOLUTION NO. 20-333

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-08-12-20-052, Schuk Toak
13 District has authorized the FY 2021 Schuk Toak District Budget, which is
14 incorporated by this reference, in the amount of \$3,074,043.86; and


15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Schuk Toak District
16 budget and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2021 Schuk Toak District Budget in the amount of \$3,074,043.86 effective
19 October 1, 2020, which shall be funded by the August 2020 District Gaming
20 Allocation.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Schuk
22 Toak District budget shall be managed and expended in accordance with Article
23 IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's
24 laws, provided that any amendments or modifications shall be authorized under
25 District Council resolution and submitted for prior approval by the Tohono
26 O'odham Legislative Council.


27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH**
28 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 2,824.3 FOR;**
29 **106.9 AGAINST; 244.5[04] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the**
30 **Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
