LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Setting September 29, 2020 Special Session to Address Tohono O'odham Nation Health Care CARES Act Budgets)

LEGISLATIVE ORDER NO. 20-334

I WHEREAS. the Legislative Council is vested with the power "to establish rules and 2 procedures to regulate all meetings of the Tohono O'odham Council, standing 3 committees, boards and special committees." (Constitution of the Tohono 4 O'odham Nation, Article VI, Section 1(a)); and 5 WHEREAS. the Legislative Rules of the Tohono O'odham Legislative Council vests the Council 6 with the authority to "by majority vote, call for a special session" (Legislative 7 Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and 8 WHEREAS. the Health and Human Services Committee has requested a special session on 9 September 29, 2020 to address the Tohono O'odham Nation Health Care CARES Act 10 budgets.
