

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Tohono O'odham Nation Healthcare CARES Act Budgets)**

RESOLUTION NO. 20-335

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Health Care ("TONHC") Governing Body has**
8 **prepared and submitted for review and approval its FY 2020 TONHC CARES Act**
9 **Budgets, which are incorporated by this reference in the total amount of**
10 **\$3,519,205.00, which shall be funded by the grantor, the Department of Health**
11 **and Human Services; and**

12 **WHEREAS, the budgets in the total amount of \$3,519,205.00 have been prepared as follows**
13 **(hereafter, collectively referred to as "FY 2020 TONHC CARES Act Budgets"):**

28 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
29 **reviewed the FY 2020 TONHC CARES Act Budgets and recommend their approval.**

30 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
31 **FY 2020 Tohono O'odham Nation Healthcare CARES Act Budgets effective March 1,**
32 **2020 in the total amount of \$3,519,205.00, which shall be funded by the grantor,**
33 **the Department of Health and Human Services Administration.**

34 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
35 **Nation chairperson or any designated official is authorized to administer and**
36 **expend the FY 2020 Tohono O'odham Nation Healthcare CARES Act Budgets,**
37 **provided that any amendments or modifications, shall be submitted for prior**
38 **approval by the Tohono O'odham Legislative Council.**
