

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Tohono O'odham Nation Healthcare CARES Act COVID-19
Hazard Pay and Paycheck Protection Program Budgets)

RESOLUTION NO. 20-336

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Healthcare ("TONHC") Governing Body has prepared**
8 **and submitted for review and approval its FY 2021 Tohono O'odham Nation**
9 **Healthcare CARES Act COVID-19 Hazard Pay Budget in the amount of**
10 **\$4,412,239.00 and Paycheck Protection Program Budget in the amount of**
11 **\$5,204,654.00, which are incorporated by these references and which shall be**
12 **funded by the grantor, the Department of Health and Human Services; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2021 Tohono O'odham Nation Healthcare CARES Act COVID-19**
15 **Hazard Pay and Paycheck Protection Program Budgets and recommend their**
16 **approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2021 Tohono O'odham Nation Healthcare CARES Act COVID-19 Hazard Pay**
19 **Budget, effective March 1, 2020 through September 30, 2021, in the amount of**
20 **\$4,412,239.00, and the Paycheck Protection Program Budget, effective October 1,**
21 **2020 through September 30, 2021, in the amount of \$5,204,654.00, which shall be**
22 **funded by the grantor, the Department of Health and Human Services**
23 **Administration.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2021 Tohono O'odham Nation Healthcare CARES Act COVID-19**
27 **Hazard Pay and Paycheck Protection Program Budgets, provided that any**
28 **amendments or modifications shall be submitted for prior approval by the**
29 **Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
31 **day of SEPTEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
32 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
