

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting the Tohono O'odham Nation Administrative Plan 2019-2023)**

RESOLUTION NO. 20-340

1 **WHEREAS, the Constitution of the Tohono O'odham Nation, Article VII, Section 2(a) provides**
2 **the Chairman with the power to oversee the administration and management of**
3 **the government in accordance with the administrative plan adopted by the**
4 **Tohono O'odham Legislative Council; and**

5 **WHEREAS, the Chairman of the Tohono O'odham Nation has submitted to the Legislative**
6 **Council his Administrative Plan that aims to propel the Nation forward by**
7 **addressing the current and future needs of the Nation through the**
8 **implementation of projects through specific strategies linked to his Vision and**
9 **Core Values; and**


10 **WHEREAS, the Administrative Plan also recognizes the dual oversight of the Office of the**
11 **Attorney General and the Office of the Treasurer by the Legislative Council and by**
12 **the Nation's Chairman and Vice-Chairwoman; and**

13 **WHEREAS, the Administrative Plan was presented to the Legislative Council for review and**
14 **consideration.**

15 **NOW THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council adopts the**
16 **Tohono O'odham Nation Administrative Plan 2019-2023; provided that (1) any**
17 **changes to the Plan or the organization chart in the Plan shall be submitted to the**
18 **Legislative Council for prior approval and (2) any conflict between the**
19 **organization chart in the Plan and organization chart approved by resolution**
20 **with executive branch budgets shall be governed by the charts approved with**
21 **budgets.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
23 **day of OCTOBER, 2020 at a meeting at which a quorum was present with a vote of 2,961.9 FOR;**
24 **~~0~~ AGAINST; [01] NOT VOTING; and 213.8 [02] ABSENT, pursuant to the powers vested in the**
25 **Council by Article VII, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
28 **Act of June 18, 1934 (48 Stat.984).**
