9	WHEREAS,	Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
10		O'odham Legislative Council shall determine whether an application is approved
11		for membership and its determination, along with the resolution number and
12		date of enactment, shall be provided to the applicant; and
13	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving
14		membership and adoption applications misspelled or incorrectly listed the
15		names of members; and
16	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 98-083, 03-
17		003, 03-463, 04-109, and 09-066 be amended to reflect the correct name for the
18		members identified in the October 2020 Corrected Enrollment Resolution
19		Summary, which is incorporated by this reference.
