

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Valley Emergency Communications Center Subscriber Services
Agreement Between the Tohono O'odham Nation and Drexel Heights Fire District)**

RESOLUTION NO. 20-349

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "[t]o consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**
5 **or with private persons or organizations on all matters within the authority of the**
6 **Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and**

7 **WHEREAS, the Tohono O'odham Nation entered an Emergency Dispatch Services Agreement**
8 **with the Drexel Heights Fire District on or about August 16, 2002, which has been**
9 **extended annually; and**

10 **WHEREAS, the Drexel Heights Fire District is now the Managing Administrative Principal of**
11 **the Valley Emergency Communications Center; and**

12 **WHEREAS, under the Subscriber Services Agreement, the Valley Emergency**
13 **Communications Center will provide emergency dispatch services to the Tohono**
14 **O'odham Nation Fire Department for the Nation's San Xavier District at a cost of**
15 **\$12,500.00 per quarter; and**

16 **WHEREAS, the parties have agreed to execute the Subscriber Services Agreement, which is**
17 **attached and incorporated by this reference; and**

18 **WHEREAS, pursuant to 26 Tohono O'odham Code Chapter 1, Article 4 – Contracting and**
19 **Procurement Authority, intergovernmental agreements require approval by the**
20 **Legislative Council; and**

21 **WHEREAS, the Domestic Affairs Committee has reviewed the terms of the Subscriber**
22 **Services Agreement and recommends its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2021 Valley Emergency Communications Center Subscriber Services**
25 **Agreement between the Tohono O'odham Nation and Drexel Heights Fire District**
26 **in substantially the form attached.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
28 **day of OCTOBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**




