

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 San Xavier District Budget Amendment No. 1)**

RESOLUTION NO. 20-358

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021 San Xavier District Budget in the amount of \$8,784,825.35 was
13 authorized by San Xavier District Council Resolution No. SXDC 08-20-14 and
14 approved by Legislative Council Resolution No. 20-325; and

15 **WHEREAS,** by Resolution No. 20-226, the Legislative Council approved the FY 2021 Tohono
16 O'odham Nation Coronavirus Relief Fund Budget, funded by the CARES Act
17 Coronavirus Relief Fund; and

18 **WHEREAS,** the San Xavier District applied for and received grant funds from the FY 2021
19 Tohono O'odham Nation's Coronavirus Relief Fund Budget in the amount of
20 \$1,277,292.11 to fund COVID-19 matters affecting the San Xavier District; and

21 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 09-20-03, the San Xavier
22 District has authorized and submitted for review and approval its FY 2021 San
23 Xavier District Budget Amendment No. 1, which is incorporated by this reference
24 and which will adjust operational and/or personnel line items; and

25 **WHEREAS,** the FY 2021 San Xavier District Budget Amendment No. 1 will increase the FY 2021
26 San Xavier District Budget by \$1,277,292.11 from \$8,784,825.35 to \$10,062,117.46
27 by incorporating the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund
28 Budget grant funds; and

29 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 San Xavier District
30 Budget Amendment No. 1 and recommends its approval.

31 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
32 FY 2021 San Xavier District Budget Amendment No. 1, which includes a
33 \$1,277,292.11 increase from \$8,784,825.35 to \$10,062,117.46 effective March 13,
34 2020 through December 30, 2020, that shall be funded by the FY 2021 Tohono
35 O'odham Nation Coronavirus Relief Fund Budget.



1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 San
2 **Xavier District Budget** as amended shall be managed and expended in
3 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**
4 **Nation and the Nation's laws, provided that any amendments or modifications**
5 **shall be authorized under a District Council resolution and submitted for prior**
6 **approval by the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
8 **day of OCTOBER, 2020 at a meeting at which a quorum was present with a vote of 2,265.4 FOR;**
9 **910.3 AGAINST; [02] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council**
10 **by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the**
11 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
13 **18, 1934 (48 Stat.984).**
