

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 20-135 "Acceptance of the City of Tucson High Intensity Drug
Trafficking Area Grant Agreement for the Native American Targeted Investigations of Violent
Enterprises and approving the FY 2020 Budget" to Correct Dates)

RESOLUTION NO. 20-359

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized to "consult, negotiate and
2 conclude agreements and contracts on behalf of the Tohono O'odham Nation
3 with Federal, State and local governments and other Indian tribes or their
4 departments, agencies, or political subdivisions, or with private persons or
5 organizations on all matters within the authority of the Tohono O'odham
6 Council" and to "manage any funds within the exclusive control of the Tohono
7 O'odham Nation . . . and to appropriate these funds for the benefit of the nation
8 and its members" provided that "[a]ll expenditures of these funds shall be
9 pursuant to appropriations or budgets" authorized by resolution or ordinance
10 (Constitution of the Tohono O'odham Nation, Article VI, Section 1(f) and Section
11 1(d)(2)); and

12 **WHEREAS,** by Resolution No. 20-135, the Legislative Council accepted the City of Tucson High
13 Intensity Drug Trafficking Area Grant Agreement for the Native American
14 Targeted Investigations of Violent Enterprises ("HIDTA") and approved the
15 accompanying FY 2020 Budget for the effective dates of January 1, 2019 to
16 December 31, 2019; and

17 **WHEREAS,** because the third and fourth whereas clauses of Resolution No. 20-135 incorrectly
18 referenced December 31, 2019 as the expiration date for both the Grant
19 Agreement and the FY 2020 Department of Public Safety City of Tucson HIDTA
20 Budget, it is necessary to amend Resolution No. 20-135 to reflect the accurate
21 dates of January 1, 2019 to December 31, 2020; and

22 **WHEREAS,** the Domestic Affairs Committee has reviewed the amendment to Resolution No.
23 20-135 and recommends approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves
25 amending the third and fourth whereas clauses of Resolution No. 20-135 to
26 correct the dates for the City of Tucson High Intensity Drug Trafficking Area Grant
27 Agreement No. HT-19-2923 and FY 2020 Department of Public Safety City of
28 Tucson High Intensity Drug Trafficking Area Budget to January 1, 2019 through
29 December 31, 2020.
