11	WHEREAS,	fees for services for these twelve Attorney Contracts will be paid by the FY 2021
12		Tohono O'odham Nation's Office of Attorney General Operating Budget; and
13	WHEREAS,	the Domestic Affairs Committee has reviewed the twelve FY 2021 Attorney
14		Contracts and recommends approval.
15	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:
16		1. Approves the twelve Attorney Contracts for FY 2021 for the Office of
17		Attorney General, which shall be funded from the Office of the Attorney

19		September 30, 2021.
20		2. Authorizes the Tohono O'odham Nation chairperson to execute the twelve
21		Attorney Contracts in substantially the form attached.
