3		rights of the Tohono O'odham Nation" and to "consult, negotiate and conclude
4		agreements and contracts on behalf of the Tohono O'odham Nation with Federal,
5		State and local governments and other Indian tribes or their departments,
6		agencies, or political subdivisions, or with private persons or organizations on all
7		matters within the authority of the Tohono O'odham Council." (Constitution of
8		the Tohono O'odham Nation, Article VI, Section 2(a) and Section 1(f)); and
9	WHEREAS,	the Legislative Council is further authorized "to manage any funds within the
10		exclusive control of the Tohono O'odham Nation and to appropriate these
11		funds for the benefit of the nation and its members" provided that "[a]ll
12		expenditures of these funds shall be pursuant to appropriations or budgets"
13		authorized by resolution or ordinance (Constitution of the Tohono O'odham
14		Nation, Article VI, Section 1(d)(2)); and
15	WHEREAS,	attorney contracts on behalf of the Nation require Legislative Council approval
16		(26 Tohono O'odham Code Chapter 1, Article 4); and
17	WHEREAS,	the Office of Attorney General requires the legal services of the Law Offices of
18		Kevin G. Hunter PLLC to represent the Tohono O'odham Nation in gaming and
19		related matters; and
20	WHEREAS,	the Office of Attorney General has prepared and submitted for review and
21		approval the FY 2021 Attorney Contract with the Law Offices of Kevin G. Hunter
22		PLLC ("Contract"), which is incorporated by this reference; and
23	WHEREAS,	the Gaming Negotiating and Domestic Affairs Committees have reviewed and
24		recommend approval of the FY 2021 Attorney Contract with the Law Offices of
25		Kevin G. Hunter PLLC.
26	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
27		FY 2021Attorney Contract with the Law Offices of Kevin G. Hunter PLLC for the
28		period of October 1, 2020 to September 30, 2021, which shall be funded by the
29		Tohono O'odham Gaming Enterprise pursuant to 16 T.O.C Chapter 2, Section
30		7(b)(6).
31	BE IT FINALI	LY RESOLVED that the Tohono O'odham Legislative Council authorizes and directs
32		the Nation's chairperson to execute the Contract, provided that if the Legislative
33		Council fails to appropriate or authorize the expenditure of sufficient funds to
34		provide for payment under the Contract, the Contract shall terminate on the date
