

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 184-83, 02-280, 03-153, 04-109, 05-607, 06-511
and 07-236 to Correct Names of Enrolled Members)

RESOLUTION NO. 20-372

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making recommendations to the Legislative Council regarding the eligibility of**
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
10 **O'odham Legislative Council shall determine whether an application is approved**
11 **for membership and its determination, along with the resolution number and**
12 **date of enactment, shall be provided to the applicant; and**


13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
14 **membership and adoption applications misspelled or incorrectly listed the**
15 **names of members; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 184-83, 02-**
17 **280, 03-153, 04-109, 05-607, 06-511 and 07-236 be amended to reflect the correct**
18 **name for the members identified in the November 2020 Corrected Enrollment**
19 **Resolution Summary, which is incorporated by this reference.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **Nos. 184-83, 02-280, 03-153, 04-109, 05-607, 06-511 and 07-236 are amended upon**
22 **the effective date of those resolutions to reflect the correct name for the members**
23 **identified in the November 2020 Corrected Enrollment Resolution Summary.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH**
25 **day of NOVEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
26 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
27 **Article II, Section 1 and Section 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
28 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**
29 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**
30 **to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
