

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting Institute of Museum and Library Services Native American Enhancement**  
**Grant and Approving FY 2021 Department of Education Institute of Museum**  
**and Library Services Enhancement Grant Budget)**

**RESOLUTION NO. 20-375**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Nation received the Institute of Museum and Library Services Native**  
8 **American Enhancement Grant Award in the amount of \$37,769.00 for the period**  
9 **of September 1, 2020 to August 31, 2021 for the Laptop and Wi-Fi Lending Project;**  
10 **and**

11 **WHEREAS, the Department of Education has prepared and submitted for review and**  
12 **approval its FY 2021 Department of Education Institute of Museum and Library**  
13 **Services Enhancement Grant Budget, which is incorporated by this reference, in**  
14 **the amount of \$37,769.00 to be funded by the Nation's general fund pending**  
15 **reimbursement by the grantor, the Institute of Museum and Library Services; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
17 **reviewed the FY 2021 Department of Education Institute of Museum and Library**  
18 **Services Enhancement Grant Budget and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**  
20 **Institute of Museum and Library Services Native American Enhancement Grant**  
21 **Award in the amount of \$37,769.00 and approves the FY 2021 Department of**  
22 **Education Institute of Museum and Library Services Enhancement Grant Budget**  
23 **effective September 1, 2020 to August 31, 2021 in the amount of \$37,769.00, which**  
24 **shall be funded by the Nation's general fund pending reimbursement by the**  
25 **grantor, the Institute of Museum and Library Services.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
27 **Nation chairperson or any designated official is authorized to administer and**  
28 **expend the FY 2021 Department of Education Institute of Museum and Library**  
29 **Services Enhancement Grant Budget, provided that any amendments or**  
30 **modifications shall be submitted for prior approval by the Tohono O'odham**  
31 **Legislative Council.**
