2		the power to "provide for, appoint, or provide for the appointment of, and
3		prescribe the duties and powers of committees, boards, officers and agents"
4		(Constitution, Article VI, Section 1(b)); and
5	WHEREAS,	the Legislative Council has enacted and subsequently amended the "Charter of
6		the Tohono O'odham Gaming Enterprise" ("Charter") at 16 Tohono O'odham Code
7		Chapter 2, which established a Management Board ("Board") that exercises
8		general authority and responsibility for the management and operation of the
9		Gaming Enterprise (16 Tohono O'odham Code Chapter 2, Section 5(d)(1)); and
10	WHEREAS,	Board directors shall be appointed for terms of three years or until their
11	WHEREAS,	
		successors are appointed and qualified (16 Tohono O'odham Code Chapter 2,
12		Section 5(a)(4)); and
13	WHEREAS,	Section 5(a)(2) of the Charter provides that "Directors shall be appointed by the
14		Chairperson of the Nation with the approval of the Legislative Council"; and
15	WHEREAS,	the Chairperson of the Nation has appointed Jacob Moore to the Tohono O'odham
16		Gaming Enterprise Board, subject to Legislative Council approval; and
17	WHEREAS,	the Commerce and Rules Committees have reviewed the Chairperson's
18		appointment and recommend approval.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		appointment of Jacob Moore to the Tohono O'odham Gaming Enterprise
21		Management Board to replace holdover Management Board Director Edward
22		Francisco for a term beginning on the effective date of this resolution and
23		expiring September 30, 2023, provided that Jacob Moore shall continue to serve
24		until his successor has been appointed and qualified.
