

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of the Arizona Attorney General's Office Law Enforcement Safety
Equipment Funding and Approving the FY 2021 Arizona Attorney General's
Office Law Enforcement Safety Equipment Funding Budget)**

RESOLUTION NO. 20-378

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Public Safety Police Department applied for and was awarded**
8 **the Arizona Attorney General's Office Law Enforcement Safety Equipment**
9 **Funding; and**

10 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
11 **approval its FY 2021 Arizona Attorney General's Office Law Enforcement Safety**
12 **Equipment Funding Budget, which is incorporated by this reference, in the**
13 **amount of \$27,000.00 with no indirect cost charges, to be funded by the Nation's**
14 **general fund pending reimbursement by the grantor, Arizona Attorney General's**
15 **Office; and**

16 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
17 **2021 Department of Public Safety Arizona Attorney General's Office Law**
18 **Enforcement Safety Equipment Funding Budget and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

20 **(1) accepts the Arizona Attorney General's Office Law Enforcement Safety**
21 **Equipment Funding; and**

22 **(2) approves the FY 2021 Arizona Attorney General's Office Law Enforcement**
23 **Safety Equipment Funding Budget, effective October 1, 2020, in the**
24 **amount of \$27,000 with no indirect cost charges, which shall be funded by**
25 **the Nation's general fund pending reimbursement from the grantor,**
26 **Arizona Attorney General's Office.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2021 Department of Public Safety Arizona Attorney General's Office**
30 **Law Enforcement Safety Equipment Funding Budget, provided that any**
31 **amendments or modifications shall be submitted for prior approval by the**
32 **Tohono O'odham Legislative Council.**


