The management of these funds shall be only by 5 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 by Resolution No. 20-240, the Legislative Council approved and authorized the FY WHEREAS. 2020 Apportionment of Mining Royalties to the districts by equal distribution; 13 14 and 15 by Sells District Council Resolution No. SD-110-20, the Sells District has WHEREAS, 16 authorized and submitted for review and approval the FY 2021 Sells District Ge 17 Oidag Community Mining Royalties Budget, which is incorporated by this 18 reference, in the amount of \$29,131.17 to be funded by FY 2020 District Mining 19 Allocation funds; and 20 WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Sells District Ge 21 Oidag Community Mining Royalties Budget and recommends its approval. 22 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 23 FY 2021 Sells District Ge Oidag Community Mining Royalties Budget in the 24 amount of \$29,131.17 effective October 1, 2020, which shall be funded by FY 2020 25 District Mining Allocation funds. 26 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Sells 27 District Ge Oidag Community Mining Royalties Budget shall be managed and 28 expended in accordance with Article IX, Section 7 of the Constitution of the 29 Tohono O'odham Nation and the Nation's laws, provided that any amendments or 30 modifications shall be authorized under District Council resolution and 31 submitted for prior approval by the Tohono O'odham Legislative Council. 32
