

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Sells District Sells Community Mining Royalties Budget)**

RESOLUTION NO. 20-387

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** by Resolution No. 20-240, the Legislative Council approved and authorized the FY
13 **2020 Apportionment of Mining Royalties to the districts by equal distribution;**
14 **and**

15 **WHEREAS,** by Sells District Council Resolution No. SD-114-20, the Sells District has
16 **authorized and submitted for review and approval the FY 2021 Sells District Sells**
17 **Community Mining Royalties Budget, which is incorporated by this reference, in**
18 **the amount of \$29,131.18 to be funded by FY 2020 District Mining Allocation funds;**
19 **and**

20 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Sells District Sells
21 **Community Mining Royalties Budget and recommends its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
23 **FY 2021 Sells District Sells Community Mining Royalties Budget in the amount of**
24 **\$29,131.18 effective October 1, 2020, which shall be funded by FY 2020 District**
25 **Mining Allocation funds.**

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Sells
27 **District Sells Community Mining Royalties Budget shall be managed and**
28 **expended in accordance with Article IX, Section 7 of the Constitution of the**
29 **Tohono O'odham Nation and the Nation's laws, provided that any amendments or**
30 **modifications shall be authorized under District Council resolution and**
31 **submitted for prior approval by the Tohono O'odham Legislative Council.**


