1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2	!	the power to enact laws "to promote, protect and provide for public health, peace,
3		morals, education and general welfare of the Tohono O'odham Nation and its
4		members" (Constitution, Article VI, Section 1(c)(2)); and
5	WHEREAS,	the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally
6	1	designated housing entity in accordance with the Native American Housing
7		Assistance and Self-Determination Act of 1996, 25 U.S.C. § 4101, et seq., P.L. 104-
8		330, 110 Stat. 4106 ("NAHASDA") and is authorized to receive and administer the
9		Indian Housing Block Grant ("IHBG") and to seek other funds to operate and
10	[	expand affordable housing; and
11	WHEREAS,	the TOKA wishes to continue providing new affordable housing to meet the needs
12		of community members by submitting a 2020 competitive IHBG application for
13		\$5,000,000.00 to the Department of Housing and Urban Development and to
14		leverage these funds with the Indian Housing Block Grant for the construction of
15		20 low-income new homeownership housing units to serve and improve the
16	1	quality of life for tribal community members; and
17	WHEREAS,	the TOKA Board and Housing Committee have reviewed TOKA's 2020 competitive
18		Indian Housing Block Grant application and recommend approval.
19	NOW, THERE	FORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:
20		1. the TOKA is authorized to submit the 2020 competitive IHBG application
21		in the amount of \$5,000,000.00 and to leverage these funds with the Indian
22	İ	Housing Block Grant to construct 20 new low-income homeownership
23		housing units; and
24		2. the Nation certifies and confirms that it will assume environmental
25		responsibilities under 24 CFR Part 58.
26	BE IT FINALL	Y RESOLVED that the Tohono O'odham Legislative Council authorizes and directs
27		the Nation's chairperson or any designated official to execute all documents
28		necessary for the TOKA to submit the 2020 competitive IHBG application and any
29		documents that may require the chairperson's signature post award, including
30		the environmental review.
