

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Sif-Oidak District Carry Forward Novel Coronavirus

RESOLUTION NO. 20-396

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS, the FY 2020 Sif-Oidak District Novel Coronavirus (COVID-19) Community Budget**
13 **in the amount of \$400,000.00 was authorized by Sif-Oidak District Council**
14 **Resolution No. SODC 20-045 and approved by Legislative Council Resolution No.**
15 **20-147; and**

16 **WHEREAS, by Sif-Oidak District Council Resolution No. SODC 20-109, the Sif-Oidak District**
17 **has authorized and submitted for review and approval the FY 2021 Sif-Oidak**
18 **District Carry Forward Novel Coronavirus (COVID-19) Community Budget, which**
19 **is incorporated by this reference, in the amount of \$388,057.60 to be funded by FY**
20 **2020 Sif-Oidak District Novel Coronavirus (COVID-19) Community Budget**
21 **carryover funds; and**

22 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2021 Sif-Oidak District**
23 **Carry Forward Novel Coronavirus (COVID-19) Community Budget and**
24 **recommends its approval.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
26 **FY 2021 Sif-Oidak District Carry Forward Novel Coronavirus (COVID-19)**
27 **Community Budget in the amount of \$388,057.60 effective October 1, 2020 that**
28 **shall be funded by FY 2020 Sif-Oidak District Novel Coronavirus (COVID-19)**
29 **Community Budget carryover funds.**

30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Sif-Oidak**
31 **District Carry Forward Novel Coronavirus (COVID-19) Community Budget shall be**
32 **managed and expended in accordance with Article IX, Section 7 of the**
33 **Constitution of the Tohono O'odham Nation and the Nation's laws, provided that**
34 **any amendments or modifications shall be authorized under District Council**


