

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2021 Sif-Oidak District Carry Forward Mining Revenue**  
**Administration Budget)**

**RESOLUTION NO. 20-397**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 Sif-Oidak District Mining Revenue Administration Budget in the  
13 amount of \$1,991,685.00 was authorized by Sif-Oidak District Council Resolution  
14 No. SODC 20-026 and approved by Legislative Council Resolution No. 20-099; and

15 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 20-108, the Sif-Oidak District  
16 has authorized and submitted for review and approval the FY 2021 Sif-Oidak  
17 District Carry Forward Mining Revenue Administration Budget, which is  
18 incorporated by this reference, in the amount of \$1,853,561.00 to be funded by FY  
19 2020 Sif-Oidak District Mining Revenue Administration Budget carryover funds;  
20 and

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Sif-Oidak District  
22 Carry Forward Mining Revenue Administration Budget and recommends its  
23 approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
25 FY 2021 Sif-Oidak District Carry Forward Mining Revenue Administration Budget  
26 in the amount of \$1,853,561.00, that shall be funded by FY 2020 Sif-Oidak District  
27 Mining Revenue Administration Budget carryover funds.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Sif-Oidak  
29 District Carry Forward Mining Revenue Administration Budget shall be managed  
30 and expended in accordance with Article IX, Section 7 of the Constitution of the  
31 Tohono O'odham Nation and the Nation's laws, provided that any amendments or  
32 modifications shall be authorized under District Council resolution and  
33 submitted for prior approval by the Tohono O'odham Legislative Council.
