

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Sif-Oidak District Carry Forward Remaining Allocation
Community Budget)**

RESOLUTION NO. 20-398

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 Sif-Oidak District Gaming Revenue Budget in the amount of
13 \$2,958,976.82 was approved by Resolution No. 19-355, with a remaining balance
14 of \$345,002.46 retained by the Nation until a budget was authorized by the Sif-
15 Oidak District Council and approved by the Legislative Council; and

16 **WHEREAS,** by Resolution No. 20-100, the Legislative Council approved the FY 2020 Sif-Oidak
17 District Gaming Revenue Remaining Allocation Community Budget in the
18 amount of \$345,002.46; and

19 **WHEREAS,** by Sif-Oidak District Council Resolution No. SODC 20-110, the Sif-Oidak District
20 has authorized and submitted for review and approval the FY 2021 Sif-Oidak
21 District Carry Forward Remaining Allocation Community Budget, which is
22 incorporated by this reference, in the amount of \$241,776.85 that shall be funded
23 by FY 2020 Sif-Oidak District gaming allocation carryover funds; and

24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Sif-Oidak District
25 Carry Forward Remaining Allocation Community Budget and recommends its
26 approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2021 Sif-Oidak District Carry Forward Remaining Allocation Community
29 Budget in the amount of \$241,776.85 effective October 1, 2020 that shall be funded
30 by FY 2020 Sif-Oidak District gaming allocation carryover funds.

31 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Sif-Oidak
32 District Carry Forward Remaining Allocation Community Budget shall be
33 managed and expended in accordance with Article IX, Section 7 of the
34 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that
35 any amendments or modifications shall be authorized under District Council



resolution and submitted for prior approval by the Tohono O'odham Legislative Council.




