SODC 20-120, SODC 20-121, and 16 SODC 20-122, the Sif-Oidak District has authorized and submitted for review and 17 approval its FY 2021 Sif-Oidak District Gaming Revenue Budget Amendments No. 18 1, which are incorporated by these references and which will adjust operational 19 and/or personnel line items as follows: 20 **(1)** FY 2021 Sif-Oidak District Administration Budget Amendment No. 1, which 21 will increase the FY 2021 Sif-Oidak District Administration Budget by 22 \$60,000.00 from \$943,696.12 to \$1,003,696.12; and 23 FY 2021 Sif-Oidak District Community Services Budget Amendment No. 1, (2) 24 which will increase the FY 2021 Sif-Oidak District Community Services 25 Budget by \$100,000.00 from \$1,160,066.35 to \$1,260,066.35; and 26 WHEREAS. the Budget and Finance Committee has reviewed the FY 2021 Sif-Oidak District 27 Gaming Revenue Budget Amendments No. 1 and recommends approval. 28 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 29 FY 2021 Sif-Oidak District Gaming Revenue Budget Amendments No. 1 to be 30 funded by the FY 2018 Sif-Oidak District closeout funding as follows: 31 **(1)** FY 2021 Sif-Oidak District Administration Budget Amendment No. 1, which 32 will increase the FY 2021 Administration Budget by \$60,000.00 from 33 \$943,696.12 to \$1,003,696.12; and
