7		authority of the Tohono O'odham Council" (Constitution, Article VI, Section
8		1(d)(2) and Section 1(f)); and
9	WHEREAS,	by Resolution No. 06-258, the Tohono O'odham Nation adopted the Tohono
10		O'odham Nation Per Capita Trust (the "Trust"), to hold per capita funds for the
11	ļ	benefit of minors and legally incompetent members pursuant to resolutions of
12		the Tohono O'odham Nation and the Indian Gaming Regulatory Act; and
13	WHEREAS,	by Resolutions No. 17-552 and 20-245, the Tohono O'odham Nation approved
14		Amendments No. 1 and No. 2, respectively, to the Tohono O'odham Nation Per
15		Capita Trust; and
16	WHEREAS,	on October 16, 2020, Wells Fargo Bank, N.A., transitioned to Principal Trust
17		Company;
18	WHEREAS,	Principal Trust Company requested Amendment No. 3 to the Tohono O'odham
19		Nation Per Capita Trust, which is incorporated by this reference, to change the
20		investment authority of the Trust to be pursuant to directions of the Nation, as
21		Named Fiduciary, or an Investment Manager, if applicable, (a "Directed Trust");

23	WHEREAS,	the Investment Committee has reviewed Amendment No. 3 to the Tohono
24		O'odham Nation Per Capita Trust and recommends approval.
25	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
26		adopts Amendment No. 3 to the Tohono O'odham Nation Per Capita Trust and
27		authorizes the Tohono O'odham Nation Chairperson to execute Amendment No.
