**RESOLUTION NO. 20-403** 

1	WHEREAS,	the Tohono O'odham Legislative Council is vested with the power "to promote,
2		protect and provide for public health and general welfare of the Tohono
3		O'odham Nation and its members" and with the authority "to consult with the
4		Congress of the United States and appropriate federal agencies regarding federal
5		activities that affect the Tohono O'odham Nation" (Constitution, Article VI,
6		Section 1(c)(2) and Section 1(j)); and
7	WHEREAS,	the Community Health Aide Program Tribal Advisory Group ("CHAP TAG") was
8		formed to ensure routine partnership with tribes on the development and
9		implementation of the program; and
10	WHEREAS,	CHAP TAG's membership is composed of one primary and one alternate for each
11		of the twelve Indian Health Service Areas, including the Tucson Area, one Tribal
12		Self Governance Advisory Committee representative, and one Direct Service
13		Tribes Advisory Committee representative; and
14	WHEREAS,	by Resolution No. 20-353, the Legislative Council nominated Representative
15		Sandra Ortega for appointment as the Tucson Area representative on the CHAP
16		TAG but did not nominate an alternate to Representative Sandra Ortega; and
17	WHEREAS,	the Health and Human Services Committee recommends nominating
18		Representative Evelyn Juan Manuel for appointment as alternate to
19		Representative Sandra Ortega on the CHAP TAG.
20	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council reaffirms
21		Resolution No. 20-353, "Nominating Representative Sandra Ortega as the
22		Community Health Aide Program Tribal Advisory Group Representative," and
23		nominates Representative Evelyn Juan Manuel for appointment as alternate to
24		Representative Sandra Ortega.
25	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that any appointment
26		made pursuant to this resolution shall immediately expire if the appointed
27		representative no longer serves on the Health and Human Services Committee for
28		any reason.
