

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Additions to the Master List for the 2020 Non-Gaming Per Capita
Distribution for Eligible Tohono O'odham Adult Members)**

RESOLUTION NO. 20-408

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Tohono O'odham
2 Legislative Council with the power to "manage any funds within the exclusive
3 control of the Tohono O'odham Nation, including proceeds derived from lands
4 and resources of the Tohono O'odham Nation, and to appropriate these funds for
5 the benefit of the nation and its members" (Constitution, Article VI, Section
6 1(d)(2)); and

7 **WHEREAS,** the Legislative Council adopted the 2020 Non-Gaming Per Capita Plan by
8 Legislative Council Resolution No. 20-070 to govern a one-time non-gaming
9 revenue per capita distribution to Eligible Members of the Tohono O'odham
10 Nation; and

11 **WHEREAS,** by Resolution No. 20-244 and by Resolution No. 20-290, the Tohono O'odham
12 Legislative Council approved the Master List for the 2020 Non-Gaming Per Capita
13 Distribution for Eligible Tohono O'odham Adult Members and approved the total
14 number of verified Eligible Tohono O'odham Adult Members for the 2020 Non-
15 Gaming Per Capita as 25,047 members; and

16 **WHEREAS,** the Tohono O'odham Membership Services Enrollment Program has identified
17 five adult members who were left off the Master List for the 2020 Non-Gaming Per
18 Capita and has identified the additional adult members in the December 2020
19 Certification Listing of an Adult Member for the Non-Gaming Per Capita
20 Distribution, which is incorporated by this reference; and

21 **WHEREAS,** Tohono O'odham Membership Services has prepared and submitted to the
22 Tohono O'odham Legislative Council the additions to the Master List for Eligible
23 Tohono O'odham Adult Members for review and approval for the 2020 Non-
24 Gaming Per Capita Distribution; and

25 **WHEREAS,** the total number of Eligible Tohono O'odham Adult Members for the 2020 Non-
26 Gaming Per Capita is 25,052 members; and

27 **WHEREAS,** the disbursement of funds to each Eligible Tohono O'odham Adult Member is
28 contingent upon verification of a member and further certification by the Tohono
29 O'odham Legislative Council; and

30 **WHEREAS,** the Rules Committee has reviewed the Additions to the Master List for the 2020
31 Non-Gaming Per Capita Distribution for Eligible Tohono O'odham Adult
32 Members and recommends its approval.



1 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
2 **Additions to the Master List for the 2020 Non-Gaming Per Capita Distribution for**
3 **Eligible Tohono O'odham Adult Members for use by Membership Services in the**
4 **administration of the 2020 Non-Gaming Per Capita Plan provided that:**


- 5 (1) **Disbursement of the 2020 Non-Gaming Per Capita payment to each**
6 **Eligible Tohono O'odham Adult Member is contingent upon verification of**
7 **a member's eligibility and further certification by the Tohono O'odham**
8 **Legislative Council.**
- 9 (2) **Approval of the Master List shall not constitute the enrollment of any**
10 **person that is not otherwise duly enrolled in accordance with the**
11 **Constitution and laws of the Tohono O'odham Nation.**
- 12 (3) **The Master List may be corrected by resolution of the Tohono O'odham**
13 **Legislative Council.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
15 **day of DECEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
16 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
17 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
18 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat.984).**


