

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2021 San Xavier District Budget Amendment No. 2)**

**RESOLUTION NO. 20-417**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2021 San Xavier District Budget in the amount of \$8,784,825.35 was  
13 authorized by San Xavier District Council Resolution No. SXDC 08-20-14 and  
14 approved by Legislative Council Resolution No. 20-325 and subsequently  
15 amended by San Xavier District Council Resolution No. SXDC 09-20-03 and  
16 approved by Legislative Council Resolution No. 20-358 in the amount of  
17 \$10,062,117.46; and

18 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 11-20-05, the San Xavier  
19 District has authorized and submitted for review and approval its FY 2021 San  
20 Xavier District Budget Amendment No. 2, which is incorporated by this reference  
21 and which will adjust operational and/or personnel line items; and

22 **WHEREAS,** the FY 2021 San Xavier District Budget Amendment No. 2 will increase the FY 2021  
23 San Xavier District Budget by \$257,225.64 from \$10,062,117.46 to \$10,319,343.10  
24 by incorporating additional grant funds from the FY 2021 Tohono O'odham  
25 Nation Coronavirus Relief Fund Budget; and

26 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 San Xavier District  
27 Budget Amendment No. 2 and recommends its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
29 FY 2021 San Xavier District Budget Amendment No. 2, which includes a  
30 \$257,225.64 increase from \$10,062,117.46 to \$10,319,343.10 effective March 13,  
31 2020 through December 30, 2020, that shall be funded by the FY 2021 Tohono  
32 O'odham Nation Coronavirus Relief Fund Budget.

33 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 San  
34 Xavier District Budget as amended shall be managed and expended in  
35 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
