

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting Donation from ARCpoint Labs of Tucson and Approving FY 2021**  
**Sells District Administration One-Time Donation Budget)**

**RESOLUTION NO. 20-420**

1 **WHEREAS,** pursuant Article IX, Section 7 of the Constitution of the Tohono O'odham Nation,  
2 No district council shall expend district funds except pursuant to budgets  
3 authorized under resolutions of the district council and approved by the  
4 Tohono O'odham Council. The management of these funds shall be only by  
5 the treasurer or other authorized officer of the district council who has  
6 furnished a surety bond satisfactory to the treasurer of the Tohono  
7 O'odham Nation, and all expenditures of these funds shall be by checks  
8 signed by such treasurer or other authorized officer and the chairman or  
9 vice chairman of the district council.

11 **WHEREAS,** the Sells District received a \$1,000.00 donation from ARCpoint Labs of Tucson for  
12 Christmas gifts for the children of Sells District; and

13 **WHEREAS,** by Sells District Council Resolution No. SD-128-20, the Sells District has  
14 authorized and submitted for review and approval its FY 2021 Sells District  
15 Administration One-Time Donation Budget, which is incorporated by this  
16 reference, in the amount of \$1,000.00; and

17 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Sells District  
18 Administration One-Time Donation Budget and recommends its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the  
20 donation from ARCpoint Labs of Tucson and approves the FY 2021 Sells District  
21 Administration One-Time Donation Budget effective October 1, 2020 in the  
22 amount of \$1,000.00.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 Sells  
24 District Administration One-Time Donation Budget shall be managed and  
25 expended in accordance with Article IX, Section 7 of the Constitution of the  
26 Tohono O'odham Nation and the Nation's laws, provided that any amendments or  
27 modifications shall be authorized under District Council resolution and  
28 submitted for prior approval by the Tohono O'odham Legislative Council.

29 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>  
30 day of DECEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;  
31 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
32 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
33 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
34 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
35 (48 Stat.984).
