

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2021 Planning and Economic Development Roads Program**  
**Cowlic Road Project Budget)**

**RESOLUTION NO. 20-424**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation was awarded \$1,500,000 for the design and**  
8 **construction of Cowlic Road, which was first authorized for expenditure by**  
9 **Resolution No. 14-499; and**

10 **WHEREAS, the BIA Western Region Office awarded a no-cost extension for the design and**  
11 **construction of the Cowlic Road Project to September 30, 2021; and**

12 **WHEREAS, the Planning and Economic Development Department has prepared and**  
13 **submitted for review and approval the FY 2021 Cowlic Road Project Budget, in the**  
14 **amount of \$1,128,159.32, which is incorporated by this reference, that shall be**  
15 **funded by the Nation's general fund pending reimbursement from the grantor,**  
16 **the Bureau of Indian Affairs; and**

17 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**  
18 **have reviewed the FY 2021 Cowlic Road Project Budget and recommend its**  
19 **approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2021 Cowlic Road Project Budget in the amount of \$1,128,159.32 effective**  
22 **October 1, 2020 that shall be funded by the Nation's general fund pending**  
23 **reimbursement from the grantor, the Bureau of Indian Affairs as referenced in**  
24 **BIAWRO Master Contract A12V01416.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation chairperson or any designated official is authorized to administer and**  
27 **expend FY 2021 Cowlic Road Project Budget provided that any amendments or**  
28 **modifications shall be submitted for prior approval by the Tohono O'odham**  
29 **Legislative Council.**




