8		Indian Affairs ("BIA") in order to perform routine road maintenance on BIA-
9		owned roads located throughout the Nation; and
10	WHEREAS,	the Tohono O'odham Nation was notified of the Grant Award, Contract No.
11		A20AV00154, in the amount of \$61,227.69 from the U.S. Bureau of Indian Affairs
12		("BIA"), effective October 1, 2019 through September 30, 2022; and
13	WHEREAS,	the Planning and Economic Development Department has prepared and
14		submitted for review and approval its FY 2021 BIA Allocated School Bus Road
15		Maintenance Project Budget, which is incorporated by this reference, in the
16		amount of \$61,227.69; and
17	WHEREAS,	the Agricultural and Natural Resources and Budget and Finance Committees
18		have reviewed the Bureau of Indian Affairs Grant Award and the FY 2021 BIA
19		Allocated School Bus Road Maintenance Project Budget and recommend their
20		approval.
21	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the
22		Bureau of Indian Affairs Grant Award in the amount of \$61,227.69, effective
23		October 1, 2019 through September 30, 2022, and approves the FY 2021 BIA
24		Allocated School Bus Road Maintenance Project Budget in the amount of
25		\$61,227.69 effective October 1, 2020, that shall be funded by the Nation's general
26		fund pending reimbursement from the grantor, the Bureau of Indian Affairs.
27	BE IT FINALI	.Y RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
28		Nation chairperson or any designated official is authorized to administer and
29		expend FY 2021 BIA Allocated School Bus Road Maintenance Project Budget,
30		provided that any amendments or modifications shall be submitted for prior
31		approval by the Tohono O'odham Legislative Council.
