by Schuk Toak District Council Resolution No. ST-08-22-20-061 and ST-11-24-20-082, the Schuk Toak District has authorized and submitted for review and approval its FY 2021 Schuk Toak District Coronavirus Relief Fund Budget, which is incorporated by this reference, in the amount of \$799,000.00 that shall be funded from the Schuk Toak Bank of America Merrill Lynch Account; and

the Budget and Finance Committee has reviewed the FY 2021 Schuk Toak District Coronavirus Relief Fund Budget and recommends its approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2021 Schuk Toak District Coronavirus Relief Fund Budget effective March 13, 2020 through December 30, 2020 in the amount of \$799,000.00, which shall be funded from the Schuk Toak Bank of America Merrill Lynch Account.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Schuk Toak District Coronavirus Relief Fund budget shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH day of DECEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>-0-</u> ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
