

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2021 San Lucy District COVID-19 Relief Funds Budget)

RESOLUTION NO. 20-444

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS,** by Resolution No. 20-226, the Legislative Council approved the FY 2021 Tohono
13 O'odham Nation Coronavirus Relief Fund Budget, funded by the CARES Act
14 Coronavirus Relief Fund; and

15 **WHEREAS,** by San Lucy District Council Resolution No. SL 12-218-20, the San Lucy District has
16 authorized and submitted for review and approval the FY 2021 San Lucy District
17 COVID-19 Relief Funds Budget, which is incorporated by this reference in the
18 amount of \$1,200,000.00 to be funded by the FY 2021 Tohono O'odham Nation
19 Coronavirus Relief Fund Budget as a sub-recipient; and


20 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 San Lucy District
21 COVID-19 Relief Funds Budget and recommends its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
23 **FY 2021 San Lucy District COVID-19 Relief Funds Budget effective March 1, 2020**
24 **through December 30, 2020 in the amount of \$1,200,000.00, which shall be funded**
25 **by the FY 2021 Tohono O'odham Nation Coronavirus Relief Fund Budget.**

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021 San Lucy
27 District COVID-19 Relief Funds Budget shall be managed and expended in
28 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
29 Nation and the Nation's laws, provided that any amendments or modifications
30 shall be authorized under District Council resolution and submitted for prior
31 approval by the Tohono O'odham Legislative Council.

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH
2 day of DECEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
3 -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
4 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
5 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
7 (48 Stat.984).


