5		control of the Tohono O'odham Nation and to appropriate these funds for the
6		benefit of the nation and its members" provided that "[a]ll expenditures of these
7		funds shall be pursuant to appropriations or budgets" authorized by resolution
8		or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section
9	<u> </u>	1(d)(2) and (f)); and
10	WHEREAS,	by Resolution No. 20-241, the Tohono O'odham Legislative Council approved
11		Intergovernmental Agreement No. ADHS2020-007 with the Arizona Department
12		of Health Services for Public Health Emergency Preparedness Program (the
13		"Intergovernmental Agreement") for the period July 1, 2020 through June 30,
14		2025; and
15	WHEREAS,	the Department of Health and Human Services has received the Arizona
16		Department of Health Services Public Health Services Emergency Preparedness
17		and Response Supplemental Award in the amount not to exceed \$100,000.00 for
18		the period July 1, 2020 to June 30, 2021 for supportive services for coronavirus
19		response efforts; and
20	WHEREAS,	the Department of Health and Human Services has prepared and submitted for
21		review and approval its FY 2021 Division of Community Health Services State
22		Public Health Emergency Preparedness Equipment Budget in the amount of
23		\$100,000.00, which is incorporated by this reference that shall be funded by the
24		Nation's general fund pending reimbursement from the Arizona Department of
25	!	Health Services; and
26	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
27		reviewed Amendment No. 1 to the Intergovernmental Agreement and the FY 2021
28		Department of Health and Human Services Division of Community Health
29		Services State Public Health Emergency Preparedness Equipment Budget and
30		recommends approval.

9	2021, in the amount of \$100,000.00, which shall be funded by the Nation's
10	general fund pending reimbursement from the Arizona Department of
11	Health Services.
12	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono
13	O'odham Nation chairperson or any designated official is authorized to
14	administer and expend the FY 2021 Department of Health and Human Services
15	Division of Community Health Services State Public Health Emergency
16	Preparedness Equipment Budget, provided that any amendments or
17	modifications shall be submitted for prior approval by the Tohono O'odham
18	Legislative Council.
19	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
20	Nation chairperson or any designated official is authorized to administer and
21	execute the Intergovernmental Agreement between the Arizona Department of
22	Health Services and the Nation in substantially the form attached, as amended,
23	provided that any amendments shall be submitted for prior approval by the
24	Tohono O'odham Legislative Council.
25 26	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23^{RD} day of DECEMBER, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
27	<u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>-0-</u> ABSENT, pursuant to the powers vested in the Council by
28	Article V1 (d)(2) and (3) and Section 1(f) of the Constitution of the Tohono O'odham Nation
29 30	adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
31	Act of June 18, 1934 (48 Stat.984).
