

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Sells District Ge Oidag Supplemental Gaming Budget, FY 2021
North Communities Multiyear Budget, and FY 2021 Sells Community Multi-Year
and Special Projects Budget)**

RESOLUTION NO. 21-008

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS,** by Sells District Council Resolution Nos. SD-120-20, SD-134-20, and SD-140-20, the
13 **Sells District has authorized and submitted for review and approval the following**
14 **budgets, which are incorporated by this reference:**

- 15 **1. FY 2021 Sells District Ge Oidag Community Supplemental Gaming Budget**
16 **in the amount of \$1,171,213.60, which shall be funded by FY 2020 Sells**
17 **District Ge Oidag Community Supplemental Gaming Budget carryover**
18 **funds;**
- 19 **2. FY 2021 Sells District North Communities Multiyear Budget in the amount**
20 **of \$1,133,620.59, which shall be funded by FY 2020 Sells District North**
21 **Communities Multiyear Budget carryover funds; and**
- 22 **3. FY 2021 Sells Community Multi Year Special Projects Budget in the**
23 **amount of \$1,119,557.23, which shall be funded by FY 2020 Sells**
24 **Community Multi Year Special Projects Budget carryover funds; and**

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021 Sells District
26 **Budgets listed above and recommends their approval.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
28 **following FY 2021 Sells District Budgets effective October 1, 2020:**

- 29 **1. FY 2021 Sells District Ge Oidag Community Supplemental Gaming Budget in**
30 **the amount of \$1,171,213.60, which shall be funded by FY 2020 Sells District**
31 **Ge Oidag Community Supplemental Gaming Budget carryover funds.**

7 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Sells**
8 **District Budgets identified above shall be managed and expended in accordance**
9 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
10 **the Nation's laws, provided that any amendments or modifications shall be**
11 **authorized under District Council resolution and submitted for prior approval by**
12 **the Tohono O'odham Legislative Council.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
14 **day of JANUARY, 2021 at a meeting at which a quorum was present with a vote of 2,961.9 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and 213.8[03] ABSENT, pursuant to the powers vested in the Council**
16 **by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the**
17 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat.984).**
