Community INT-01-14 Budget and recommends its approval. 16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 17 FY 2021 Sells District Kawulk Community INT-01-14 Budget in the amount of 18 \$12,406.99 effective October 1, 2020 that shall be funded by FY 2020 Sells District 19 20 Cowlic Community INT-01-14 Budget carryover funds. 21 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021 Sells District Kawulk Community INT-01-14 Budget shall be managed and expended in 22 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham 23 Nation and the Nation's laws, provided that any amendments or modifications 24 shall be authorized under District Council resolution and submitted for prior 25 26 approval by the Tohono O'odham Legislative Council. The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>04TH</u> 27 day of <u>JANUARY, 2021</u> at a meeting at which a quorum was present with a vote of <u>3,175.7</u> FOR; <u>-0-</u> 28 AGAINST; <u>-0-</u> NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by 29 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono 30 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -31 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
