

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Water Resources Department Water Revenue Budget)**

RESOLUTION NO. 21-011

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Water Resources Department has prepared and submitted for review and
8 approval its FY 2021 Water Resources Department Water Revenue Budget, which
9 is incorporated by this reference, in the amount of \$3,697,444.00 to be funded by
10 the Water Revenue Account; and

11 **WHEREAS,** the Water Resources and Budget and Finance Committees have reviewed the FY
12 2021 Water Resources Department Water Revenue Budget and recommend its
13 approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
15 FY 2021 Water Resources Department Water Revenue Budget effective October 1,
16 2020 in the amount of \$3,697,444.00, which shall be funded by the Water Revenue
17 Account.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to administer and
20 expend the FY 2021 Water Resources Department Water Revenue Budget,
21 provided that any amendments or modifications shall be submitted for prior
22 approval by the Tohono O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH
24 day of JANUARY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
25 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
26 Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
27 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
29 18, 1934 (48 Stat.984).
