

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021 Department of Health and Human Services Family
Violence Prevention Budget)

RESOLUTION NO. 21-014

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services submitted an application for a**
8 **U.S. Department of Health and Human Services Family Violence Prevention and**
9 **Services Act Grant to support emergency shelter and supportive services for**
10 **victims of domestic violence and their dependents and the Tohono O'odham**
11 **Nation received a grant award in the amount of \$224,475.00; and**

12 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
13 **review and approval its FY 2021 Family Violence Prevention Budget, which is**
14 **incorporated by this reference, in the amount of \$224,475.00 to be funded by the**
15 **Nation's general fund pending reimbursement from the U.S. Department of**
16 **Health and Human Services; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2021 Department of Health and Human Services Family Violence**
19 **Prevention Budget and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2021 Department of Health and Human Services Family Violence Prevention**
22 **Budget effective October 1, 2020 in the amount of \$224,475.00, which shall be**
23 **funded by the Nation's general fund pending reimbursement from the U.S.**
24 **Department of Health and Human Services.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer**
27 **and expend the FY 2021 Department of Health and Human Services Family**
28 **Violence Prevention Budget, provided that any amendments or modifications**
29 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
31 **day of JANUARY, 2021 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
